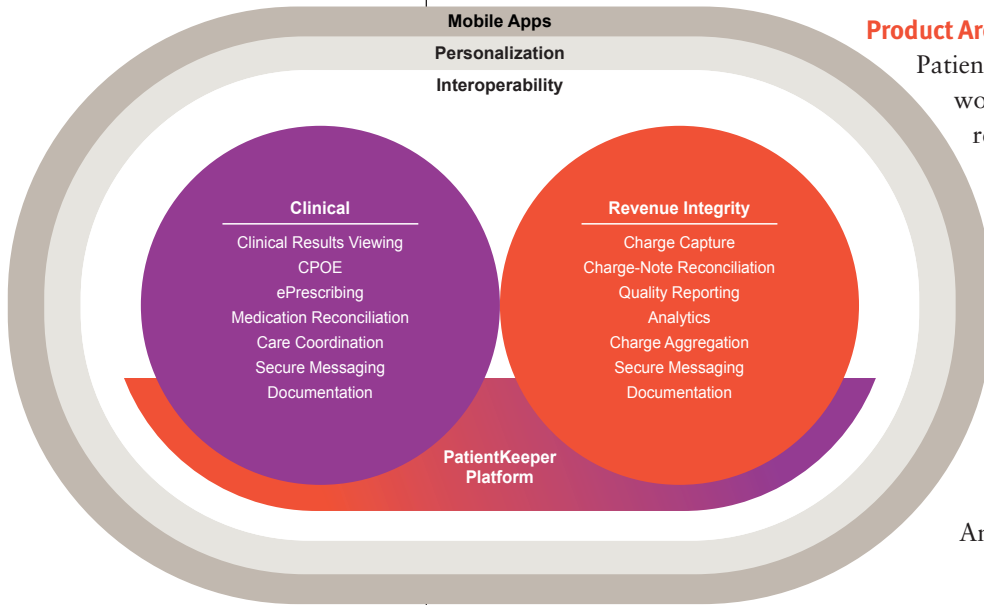

PatientKeeper is the first company to offer a digital environment for providers that integrates with an organization’s existing transactional and clinical information systems





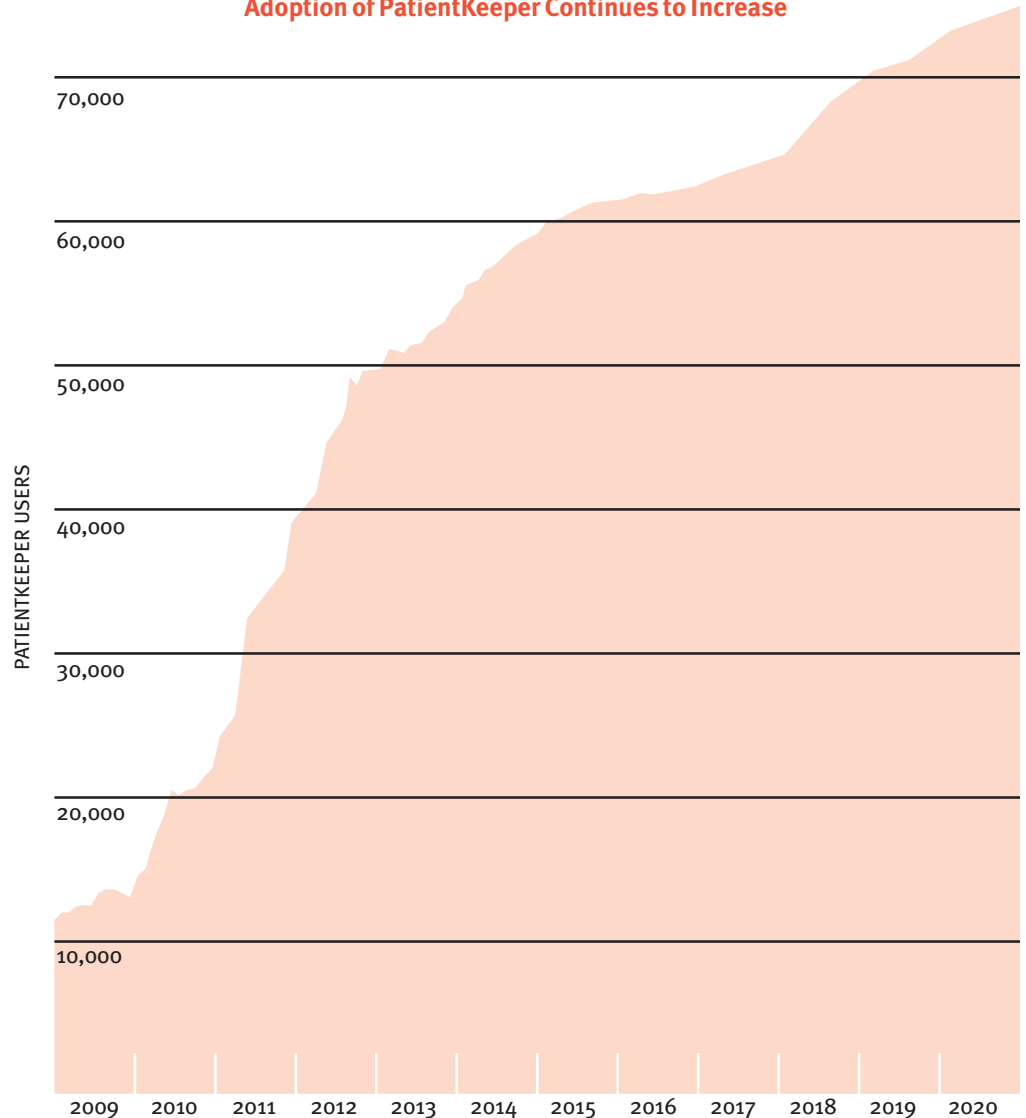
