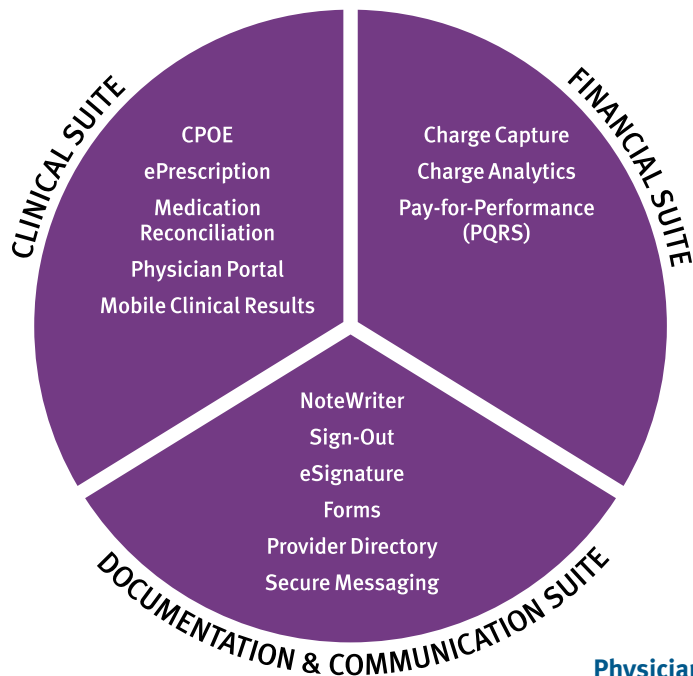

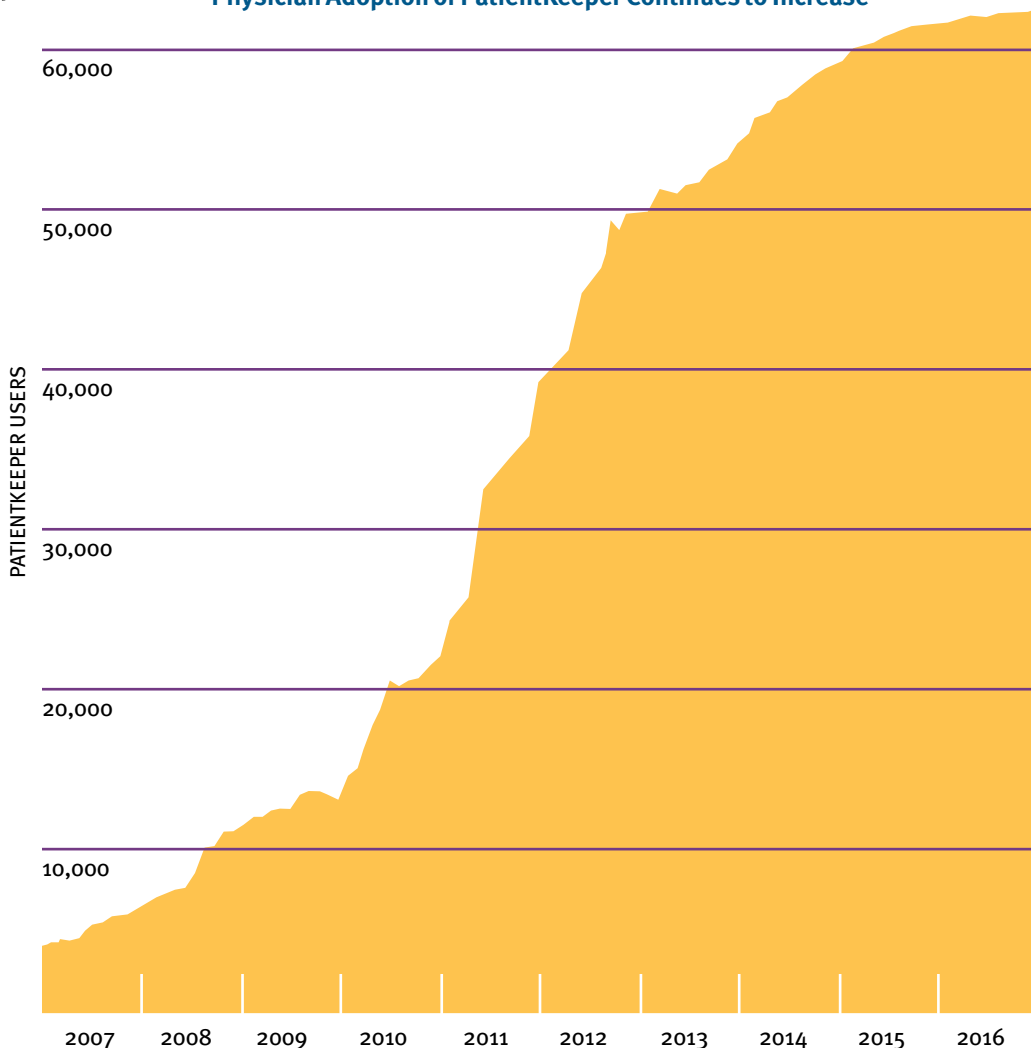
Product Areas
