
# Collect and Report Pay-for-Performance Information Including CMS's Physician Quality Reporting System

Aiming to further improve patient care, the Centers for Medicare & Medicaid Services (CMS) has defined and devised a pay-for-performance program called the Physician Quality Reporting System (PQRS) that offers compelling financial incentives. Providers can receive a bonus payment (calculated as a percentage of reimbursable dollars) if they report on at least three quality measures in 80 percent of cases where measures are reportable.



Unfortunately, gathering that quality data and reporting those measures can be challenging. Paper forms – when clinicians remember to use them in their clinical encounters – can be illegible or get lost along the way. ## Capture Quality Information in Seconds as Part of Your Regular Workflow

PatientKeeper P4P acts as a seamless add-on to the charge capture process. When you use PatientKeeper ChargeCapture to enter a charge for a set of diagnoses or procedures, PatientKeeper P4P pops up with a simple PQRS form of one or two quality data-related questions that are relevant to the charges you just recorded. There are no additional paper forms to carry (or lose) and no new codes to remember.

For example, a patient at a discharge visit with a diagnosis of congestive heart failure would qualify for reporting. After you enter the charge and diagnosis, PatientKeeper P4P automatically reminds you to report on the appropriate PQRS Quality Measure – in this case, whether or not the patient received ACE inhibitors or ARB therapy, as well as their LVEF value.

- Support for All Claims-Based CMS PQRS Measures PatientKeeper P4P captures your quality performance on all measures associated with CMS's PQRS program. These are based on unique combinations of CPT and ICD-9 codes, patient age and gender.
- Simplified Workflow Underlying logic in PatientKeeper P4P triggers the presentation of each form when appropriate/relevant for the CPT and/or ICD-9 code entered for charge-capture. Clinicians take a few additional seconds to simply answer a couple of additional questions such as, "Was antiplatelet therapy prescribed?" There are no codes to remember or steps that disrupt the clinical encounter.
- ICD-10 PatientKeeper P4P can easily support the ICD-10 migration. By simply including ICD-10 codes into the criteria to display PQRS measures, PatientKeeper continues to support the PQRS reporting initiative after October 2013. Your physicians will not need to remember the many additional codes that could make a PQRS measure reportable.
